

MARYLAND MOTOR TRUCK ASSOCIATION, INC.
Instructions for Completing the MMTA E-ZPass Application

If you are a member of Maryland Motor Truck Association (hereafter “MMTA”) in good standing, or a member of an affiliated trucking association, or a participant through BESTPASS, Inc., you are eligible to apply for an MMTA E-ZPass Business Account. This will enable your company to utilize the Maryland E-ZPass system for automated toll payment, while taking advantage of the enhanced discounts which MMTA makes available to its members through the MMTA E-ZPass Program (hereafter “the Program”). To open a Business Account under a company name, complete the attached application with the assistance of these instructions. You also need to read and sign the attached Terms and Conditions, which will govern your involvement in the Program. Once approved, you will receive a Maryland E-ZPass tag (referred to herein as a “Transponder”) which will enable the vehicle to which it is attached to participate.

PART 1. COMPANY INFORMATION

To open a Business Account under a company name, the name on the Account must be the full legal company name. Please clearly print your company information in the appropriate boxes. **Note: If you are an owner operator that is leased to a motor carrier, and are opening this account personally, you should use your name and not the name of the motor carrier you are leased to.**

PART 2. VEHICLE INFORMATION

Please provide the requested information for each vehicle listed on the Vehicle Information Form. Note: the Program is applicable to all vehicles; HOWEVER, ONLY VEHICLES WITH FIVE OR MORE AXLES ARE ELIGIBLE FOR TOLL DISCOUNTS. DISCOUNTS WILL NOT BE GIVEN TO VEHICLES WITH LESS THAN FIVE AXLES.

Enter license plate number, state of registration, number of axles and vehicle reference number. Circle the type of Transponder that you are requesting, either interior windshield, interior fusion (for use with weigh station bypass programs such as PrePass or NorPass), exterior roof mount or exterior license plate. Circle “NONE” for vehicles you are listing but do not require a Transponder for at this time.

Total Number of Axles (Box A)

Add the “Number of Axles” column and enter the total in Box A.

Total Number of Interior Windshield Transponders (Box B)

Add the number of vehicles that have “Windshield” circled. Enter the total in Box B.

Total Number of Interior Fusion Transponders (Box C)

Add the number of vehicles that have “Fusion” circled. Enter the total in Box C.

Total Number of Exterior Roof Mount Transponders (Box D)

Add the number of vehicles that have “Roof Mount” circled. Enter the total in Box D.

Total Number of Exterior License Plate Transponders (Box E)

Add the number of vehicles that have “License Plate” circled. Enter the total in Box E.

Note: Do not order an interior Transponder for vehicles that have flat (perfectly vertical) windshields or for vehicles which have any metal hanging over the windshield (i.e., visor, storage rack, boom or crane). If your vehicle fits this description, you must order an exterior Transponder.

Note: Certain vehicles are equipped with special windshields that contain metal in the glass. This prevents the Transponder from being read properly. Vehicles with such windshields must utilize an exterior Transponder. If you are unsure about whether your vehicle has one of these windshields, contact the dealer where you purchased your vehicle. If you have any questions, call 1-888-410-9696.

PART 3. PRE-PAYMENT CALCULATION

To open an account you must make an Initial Payment that includes the purchase of Transponder(s) and an advance toll payment amount for each vehicle enrolled in the Program. All Maryland toll usage for all vehicles with five or more axles on your Account is combined to calculate the amount of your monthly discount. **Note: VEHICLES WITH LESS THAN FIVE AXLES ARE**

NOT ELIGIBLE FOR TOLL DISCOUNTS.

PREPAID TOLLS

Box 1 Enter the total number of axles from Box A on Page 5.

Box 2 Multiply Box 1 by \$50. Enter the amount in Box 2.

TRANSPONDER COSTS (Prices are Subject to Change)

Box 3 Number of interior windshield Transponders. Total of Box B on Page 5 in Box 3.

Box 4 Multiply the number in Box 3 by \$9.00 and enter the amount in Box 4.

Box 5 Number of interior fusion Transponders. Total of Box C on Page 5 in Box 5.

Box 6 Multiply the number in Box 5 by \$40.00 and enter the amount in Box 6.

Box 7 Number of exterior roof mount Transponders. Total of Box D on Page 5. Enter the number in Box 7.

Box 8 Multiply the number in Box 7 by \$33.00 and enter the amount in Box 8.

Box 9 Number of exterior license plate mount Transponders. Total of Box E on Page 5. Enter the number in Box 9.

Box 10 Multiply the number in Box 9 by \$9.00 and enter the amount in Box 10.

Box 11 Total Transponder Cost. Add Boxes 4, 6, 8

and 10. Enter the amount in Box 11.

Box 12 Total Initial Payment. Total of Boxes 2 and 11. Enter the total in Box 12.

PART 4. PAYMENT METHODS

OPTION 1: DIRECT DEBIT

In order to take advantage of the direct debit option, you will need to complete and sign the Authorization for Automated Debits (and Credits) form on Page 8.

OPTION 2: CHECK OR CASH REPLENISHMENT

To replenish your Account by check or cash, select Option 2. Cash payments must be made in person at MMTA's offices. Or, send a check (or money order) payable to "Maryland Motor Truck Association, Inc.", for the amount shown in shown in Box 12 on Page 3, along with your application, to the following address:
